Town of Terry Flea and Farmer's Market Rules and Regulations

1. **Regular Vendors:** Regular vendors typically have the first right of refusal for their space each month. Please be sure to reserve those spaces right away.
2. **Reservations:** You may reserve more than one month at a time, and you must pay for every month that you reserve.
3. **Check or Money Order payable to: Terry's Flea and Farmer's Market.** This is due 2 days prior to the market. Any vendor who has not paid for the market 2 days in advance may forfeit his/her space, and/or may be moved to another spot. However, once your payment is received, your space is guaranteed.
4. **Non-Sufficient Fund Payments:** NSF's are subject to additional fees up to \$40.00 and may be turned over to collections.
5. **There are NO REFUNDS.** However, if you cannot make it to the market, but give us a 1-day notice, we will apply your payment towards another show. We may consider a refund on an individual basis, and the vendor may be asked to write a letter requesting a refund.
6. **No Call No Shows:** If a vendor fails to call or show up for a show, there is NO refund, and their check will be cashed. If no payment was received, the vendor will be required to pre-pay in advance to reserve a space at future markets.
7. **Bad Weather:** In the event of severe weather that prevents the market from opening, we will transfer your space rent to the following market. If that month does not work, we will make other arrangements at that time.
8. **Cancelled Show:** If the market is cancelled for any other reason, we will transfer the money to another market or offer a refund at that time.
9. **Asked to Leave:** We reserve the right to ask vendors to leave any market, at any time, for any reason.

It is hereby agreed and understood that I, the exhibitor will carry the necessary insurance covering pictures, art, objects, and all other items and property displayed, used and possessed by the exhibitor during any of the 2010 Terry's Flea and Farmer's Market, and hereby exonerate the Town of Terry, The Terry Business Association, Sponsors, workers, and helpers from any bodily injuries, damages or losses while setting up, attending, while in transit to and from, or anytime during any of the 2010 markets.

By signing this form, the applicant acknowledges having fully read this application and liability waiver and agrees to abide by all rules and regulations pertaining to this event for the entire season. Subsequent bookings need not require another complete application; however the rules remain in effect for any markets exhibitor attends during this season.
